

## Training to Serve Our Community

Training is the key to success in today's fire service. The Lowell Fire District volunteers recognize that and dedicate numerous hours to maintain appropriate skill and knowledge levels to continually improve service to our patrons. Our volunteers spent over 3,500 hours training in 2013. This training included 2,400 hours on fire and rescue skills and 1,100 hours on medical skills.

District personnel are trained to specific levels established by several organizations including the National Fire Protection Association (NFPA), Oregon Department of Public Safety Standards and Training (DPSST), Oregon Health Division-EMS section, Oregon-OSHA and the Oregon State Fire Marshall's Office, commensurate to the position held by each member.

Prior to gaining response status, District personnel are trained to a minimum level as required by DPSST in Hazardous Materials Operation, Infectious Disease Prevention, CPR and Emergency First Aid.

Current Volunteer membership includes: 4 residents (live at the Main Station), 1 Cadet (High school student), 7 Interns (live outside District boundaries) and 10 in District members for a total of 22 volunteers that serve the communities of Fall Creek, Unity and Lowell.

## Annual Code Enforcement Inspection Scheduled

City staff will conduct a City-wide code enforcement inspection during the last week of June. This inspection will identify properties that do not meet Lowell code regarding nuisances, noxious vegetation, vehicles and any other code violation that is readily apparent. City staff will **not** enter private property and will only be identifying violations that are clearly visible from a public street or alley. Those properties in violation will be sent a letter identifying the violation and be required to correct the violation within 10 days of being notified.

The staff will be inspecting primarily for the following:

- Accumulations of garbage, junk and debris clearly visible from a street or alley.
- Vegetation that needs to be cut back so that it doesn't impact use of sidewalks or streets.
- Tall grass which needs to be cut and weeds which are going to seed.
- Blackberry vines that extend into a public street or across a property line.
- Dismantled vehicles or vehicle parts stored on private property in clear view of the street.
- Unregistered or inoperable vehicles parked within the public right-of-way.

Copies of the ordinances which establish the standards that are expected to be met and identify what constitutes a violation are available at City Hall or on the City's website <u>www.ci.lowell.or.us</u> under the Government Page. ## City of Lowell Job Announcement Public Works Superintendent

The City of Lowell seeks an experienced professional to lead the City's Public Works Department including the operation of a Class II Water Treatment facility, Class I Water Distribution system, Class III Wastewater Treatment facility and Class II Wastewater Collection system.

**Position Description:** This position is for the management, operation and maintenance of all aspects of a water and sewer utility. The position is also responsible for performing and supervising other public works related activities, including street, storm drain and park maintenance. It also requires a willingness to work a flexible schedule including nights, weekends and holidays, and perform overtime/comp time work when essential for utility operations.

The following shows the current number of medically licensed personnel and the hours required to obtain their license and the number of training hours required to maintain their license:

- 4 Paramedics 1000 to 1200 class hours & Associate Degree, with 48 hours of training every two years
- 1 Intermediate EMT 264 class hours with 36 hours of training every two years
- 1 Advanced EMT 264 class hours with 36 hours of training every two years
- 8 EMTs 128 class hours with 24 hours of training every two years
- 7 Emergency Medical Responders 48 class hours with 12 hours of training every two years
- All personnel retain a current CPR certification.

In addition to the medical training requirements, personnel are required to receive and maintain fire fighting and rescue training as listed below.

<u>Structural Fire Suppression</u>: The following shows how many are certified and the classroom hours required to achieve certification at each level. These hours do not include hands-on skills that are required to be demonstrated and re-certified each year.

- 13 Firefighter I—80 hours (4 more will be submitting application for certification before July)
- 4 Firefighter II—45 hours
- 1 Vehicle and Machinery Rescue Technician—50 hours
- 19 Operations Level Hazardous Materials Responders—20 hours (2 are awaiting approval)
- 22 (100%) National Incident Management System Certificate—requires 7-9 individual certifications, dependent of rank and job duties – 28 to 76 hours
- 6 Fire Instructor I—40 hours
- 1 Fire Instructor II—32 hours
- 2 Fire Officer I—80 hours (2 more are currently completing requirements)
- 0 Fire Officer II—80 hours (1 will be completing requirements in late summer)

<u>Technical Rescue:</u> Hours reflect classroom time, not hands on training.

- 13 Water Rescue Awareness training-4 hours
- 3 Rope Rescue Technician—32 hours (4 currently completing requirements)
- 3 Surface Water Rescue Technician—32 hours (4 currently completing requirements)
- 3 Swiftwater Rescue Technician—24 hours

<u>Drivers</u>: Hours reflect classroom time, not hands-on training.

- 15 NFPA Driver/Operator—16 hours
- 9 NFPA Pumper Operators—32 hours
- 7 NFPA Tender Operators—32 hours
- 3 NFPA Wildland Apparatus Drivers—16 hours
- 22 or 100% District Emergency Vehicle Operations Course—16 hours
- 19 trained to drive all Staff/Rescue Apparatus (2 completing requirements)

<u>Wildland</u>: These qualifications are for the National Wildfire Coordinating Group and are transferable to all 50 states. Hours reflect classroom time, not handson.

- 22 or 100% Interface Firefighters—47 hours
- 7 Advanced Wildand Firefighters—16 hours
- 2 Engine/Crew Boss—64 hours

These numbers reflect our current status of state and federal, licensed and certified personnel. They do not reflect the personnel that are qualified to District Standard Operating Policies/Procedures. Example: Lowell RFPD has 3 NFPA Wildland Apparatus Drivers, IAW departmental standards that meet and/or exceed NFPA and we have 15 personnel capable of driving our Wildland Apparatus. The hours only reflect the class-room time to achieve the certification, they do not reflect the 60-84 annual hours required to maintain the certifications.

In addition to the qualifications listed above, we now are accredited for Maritime Rescue Boat Operator. We are only one of a handful of districts in the State of Oregon able to provide this training. We have six members currently qualified to operate the District Rescue Boat and will be holding a Maritime Rescue Boat Operators class early this summer to increase those numbers.

Positions for Auxiliary Support, Structural Firefighter, Wildland Firefighter and EMS are always available. If any of the programs sound like something you would like to do, and you have the time to commit to the organization, contact the District office at 541-937-3393 or go to www.lowellfiredistrict.org for more information and an application. We will be taking applications for Resident Volunteer positions for our new Fall Creek Station this summer also.

## Fire District Budget Committee Approves Budget

The Fire District Budget Committee met April 16<sup>th</sup> to review the proposed budget for fiscal year 2014/2015. The Committee approved a budget of \$597,960, which is approximately 5% less than the current year's budget.

The approved budget includes a 2% cost of living increase for the Training Coordinator and the half-time Fire Chief, inflationary increases in goods and services and a significant reduction in capital outlay equipment items. The only capital item scheduled is the purchase of two or three 40-foot steel shipping containers for training aids to be constructed at the Training Station in Fall Creek.

The approved budget is posted on the District web page at www.lowellfiredistrict.org or can be obtained at the District office.

A Budget Hearing is scheduled for May 21<sup>st</sup> at the Lowell Fire Station at 7:00 PM, where public comment on the proposed budget is welcome. Following the Budget Hearing the regular meeting of the Board of Directors is scheduled.
