## LOWELL SCHOOLS: We're on the Move...

The Lowell School District will be starting the **Bridge Charter Academy** to be opened for the 2016-17 school year. Bridge Charter Academy will be a Personalized Learning School designed to serve the fifteen hundred Homeschool students in Lane County. The Bridge model allows parents, teachers, and students to collaborate and customize a Learning Plan for each student. This plan focuses on the student's learning style, interests, and academic goals. Bridge Charter Academy will facilitate this personalization with access to: licensed teachers, a spectrum of quality curriculum choices, educational software, technology, assessments, and a learning cohort for interaction and encouragement.

The vision of the school is to "inspire a love for learning that produces a life-long learner". Bridge Charter Academy's approach to stimulate this enjoyment can be summarized in the following manner: (1) Through promoting and facilitating parents' direct involvement in the learning process with their children (organic to the homeschool model); (2) identifying teachers that are leaders, who are passionate, with contagious enthusiasm during scheduled group and individual time; (3) utilizing proven technology children enjoy, focusing on individual learning gaps; (4) implementing a robust reading program stimulating reading enjoyment, including "Battle of the Books".

Bridge Charter Academy has the potential to be a dynamic school with incredible growth. This has proven true with a similar model successfully implemented in Medford with Logos Charter School and their enrollment of nearly nine hundred students. The Executive Director for Bridge Charter Academy is John Vondoloski, formerly the Executive Director that created Logos Charter. Taking the experience learned from that endeavor, Bridge Charter Academy will implement a similar Personalized Learning philosophy. The emphasis of our program is to raise what has historically been called a Philomath, or lover of learning. It embraces the philosophy that a fundamental law of learning is, "the student must attend with interest" for true learning to take place. The primary focus is to tap into intrinsic motivators to help fuel the desire for learning.

The mission statement of Bridge Charter Academy is to "maximize parent, community, technological, innovative, and academic resources for historically and educationally underserved homeschool and at risk students, to produce excellence in education." In order to successfully implement a personalized and customized approach to learning, all resources possible are tapped into to design a personal learning plan. Included in this diverse model is the

intention to develop a comprehensive program to serve Alternative students that struggle with traditional models. Part of our mission is to provide hands-on approaches to a large variety of technical and vocational skills outside of a classroom environment. Working with a mentor-teacher, learning will begin with hands-on projects and transition to curriculum directed learning after the student's interest is piqued.

In collaboration with the Lowell School District and from previous experience with this type of school, the first year the Academy will start by serving grades K-9 and add an additional grade each year until it is providing a fully accredited K-12 program. This will allow the school to adequately establish its foundation before it is graduating students.

During the development of this program, Bridge Charter Academy has reached out to current homeschool families. An informational meeting was held on January 11, to explain the program and answer a multitude of questions concerning the design and implementation of the model. Positive feedback has poured in via email and social media. The desire from the beginning has been to ensure Lowell is a community that is proud of its school system. Lowell Superintendent, Dr. Walt L. Hanline, echoed the vision of the district when he said, "The foundation of Lowell School District is to provide educational options to parents and children that best serve their family".

#### **Surveillance Camera Policy Adopted**

On January 5th, the Lowell City Council adopted a video surveillance camera policy to regulate security cameras at City-owned facilities. Video surveillance, when utilized with other security measures, is an effective means of ensuring the security and safety of City facilities, the individuals who use them, and the assets housed within them. However, the need to ensure security and safety should also be balanced with an individual's right to privacy. The adopted policy provides guidelines which are intended to achieve this balance.

The policy specifically addresses requirements and responsibilities with respect to the following:

- Installation of the video surveillance system
- Operation of the video surveillance system
- Use of the information obtained through the video surveillance system
- Custody, control and access to records

Our principal goal with this new policy is to improve public safety in the City of Lowell. The first phase of the surveillance camera system will cover Paul Fisher Park, and is scheduled to be brought online in February. If successful, we plan to expand the system to include Rolling Rock Park and our other public facilities.

#### FROM THE LOWELL FIRE DISTRICT

#### **Volunteer & See What You Can Achieve**

The Lowell Rural Fire Protection District provides Fire Protection to a district of 23 square miles around Lowell, Unity and Fall Creek. The District includes rural, residential, business and forest lands as well as recreational areas.

The wide variety of protected lands and structures within the district requires our volunteers be trained in many different suppression techniques under a number of different conditions. This variety of experiences and training can prepare our volunteers for varied specialties within the fire service or give them a well rounded base knowledge for other types of employment if they so desire.

The surrounding area is home to many outdoor recreation areas that all come with natural features that require unique skills and knowledge to perform rescues. Our Volunteers receive training in rope rescue, water rescue and vehicle extrication. Learning new and valuable rescue techniques is an important part of every Volunteer's experience with the district.

Providing Emergency Medical Services to our district patrons is one of the primary services offered by the District. Volunteers are encouraged and financially supported in gaining medical certifications and licensing including Emergency Medical Responder (EMR), Emergency Medical Technician (EMT), Advanced EMT and Paramedic levels. A variety of backgrounds and levels of training enable district personnel to provide caring quality patient care to those needing help.

#### What do you have to do to get involved?

Contact district members by either dropping by the main station in Lowell or calling us at 541-937-3393.

#### Do you need previous experience?

No. All levels of experience are welcome. As long as you have a good attitude and are willing to learn, we will teach you what you need to know to be successful in our organization.

#### What are the time requirements?

If you live in the Fire District, initial training takes 5 to 6 weekends to complete. Following your initial training, attending weekly drills and responding to calls (about 4-5 hours per week) is what will be required.

We also have an Intern Program for folks that do not live in the district but want to volunteer. The Intern program requires a commitment of 8 hours a week for shift duty time and attending weekly drills. There are some weekend time commitments also.

#### How does scheduling work?

You pick your hours for the most part. Start when you can and the district will try to accommodate any schedule that helps support responses and training. For more information contact the district office at 541-937-3393 or go to www.lowellfiredistrict.org.

## Home Sprinkler Systems Can Save Lives and Property

Here are some interesting facts about Residential Fire Sprinkler Systems.

- Roughly 85% of all US fire deaths occur in the home.
- Fire sprinklers save lives, reduce property loss and can even help cut homeowner insurance premiums.
- Sprinklers are highly effective because they react so quickly in a fire. They reduce the risk of death or injury from a fire because they dramatically reduce the heat, flames and smoke produced, allowing people the time to evacuate the home.
- Home fire sprinklers can control and may even extinguish a fire in less time than it would take the fire department to arrive on the scene.
- Only the sprinkler closest to the fire will activate, spraying water directly on the fire. In 84% of home fires where the sprinklers operate, just one sprinkler operates.
- If you have a fire in your home, the risk of dying is cut by about one-third when smoke alarms are present (or about half if the smoke alarms are working), while automatic fire sprinkler systems cut the risk of dying by about 80%.
- In a home with sprinklers, the average property loss per fire is cut by about 70% (compared to fires where sprinklers are not present.)
- A Fire Protection Research Foundation report found that the cost of installing home fire sprinklers averages \$1.35 per sprinklered square foot (about \$2,700 for a 2000 square foot home or \$2,025 for a 1500 square foot home).
- Modern residential sprinklers are inconspicuous and can be mounted flush with walls or ceilings.
- Sprinklers operate in all but 5% of home fires large enough to activate the system. Human error was a factor in almost all of the failures. The system was shut-off in more than three of every five failures.
- All national <u>model safety codes</u> include fire sprinklers as a minimum safety requirement for new home construction.
