## **City Declares State of Emergency**

The Lowell City Council formally declared a local state of emergency for the City of Lowell on March 17 as a precautionary measure to provide the City with increased flexibility in terms of resources, purchasing, and emergency response options for the coronavirus (COVID-19). The declaration will be in effect through at least April 22.

This is not a declaration of a public health emergency, as that is not our role. The declaration enables the City and staff to be in the best position to serve the community where needed most. Other cities in the region have taken or are planning to take similar action.

The following measures will be in place for the duration of the local emergency to mitigate the spread of COVID-19:

- City Hall and park restrooms will be closed to the public. Residents and businesses are encouraged to complete City business online at <a href="www.ci.lowell.or.us">www.ci.lowell.or.us</a> or by calling 541-937-2157. As a reminder, utility payments are accepted via mail, drop box (next to the front door at City Hall), online at <a href="www.xpressbillpay.com">www.xpressbillpay.com</a>, or by phone through our interactive voice response system at 866-785-8380 or live operator at 800-720-6847.
- The City will not apply late penalties, send shut-off notices, or shut off water for non-payment of unpaid utility bills while this emergency is in place.
- Advisory committee meetings are cancelled for the duration of the emergency, or until and unless an alternative meeting method has been identified.
- City Council meetings will continue, but with social distancing
  modifications including increased space between chairs and
  strong encouragement of livestreaming options. The City will
  continue to monitor and consider federal, state, and local public
  health recommendations carefully in determining whether to
  cancel or continue future City Council meetings during this
  emergency.
- Public hearings necessary to meet state-mandated land use review timelines may be held with social distancing modifications as noted above.
- All City sponsored public events are canceled for the duration of the emergency. In addition, permits for special events will not be

#### **Public Notice of Intent to Abate**

In April of each year, the City is required to provide the public with a copy of LRC 5.122 regarding the abatement of noxious vegetation. Noxious vegetation is defined as poison oak; poison ivy; blackberry bushes that extend into a public thoroughfare or across a property line; vegetation that is a health hazard, fire hazard, or traffic hazard; weeds or grass more than 12 inches high; weeds or grass going to seed; and noxious vegetation does not include agricultural crops unless that crop is a health, traffic, or fire hazard. Prior to any citation or abatement action, the property owner or person in charge of property will be provided with a minimum 10 days' notice to abate the vegetation. A copy of LRC 5.122 is provided below for your reference:

"5.122 Owner Responsibility. No owner or person in charge of property may allow noxious vegetation to be on his property or on the public right-of-way abutting his property. It shall be the duty of an owner or person in charge of the property to cut down or to destroy noxious vegetation. Exception: For parcels one acre or larger in size, noxious vegetation need only be controlled for a distance of 20 feet from an adjoining property where development has occurred and is not required to be controlled adjoining undeveloped property unless specifically requested by the owner of the undeveloped property."

- Approved moving forward with a Library Capital Campaign.
- Approved the 2020 City Administrator Objectives.
- Approved Resolution 731—A resolution to apply for a Local Government Grant from the Oregon Parks and Recreation Department for Rolling Rock Park improvements.
- Approved Resolution 732—A resolution to apply for a Land and Water Conservation Fund Grant for Rolling Rock Park improvements.
- Approved Resolution 733—A resolution declaring a local state of emergency in the City of Lowell as a result of the COVID-19 (coronavirus) pandemic.

All actions were approved 4-0.

## FROM THE LOWELL FIRE DISTRICT

#### **Budget Committee Meeting April 8th**

The Lowell Rural Fire protection District will be holding their Budget Committee Meeting on April 8<sup>th</sup>, 2020. Due to the current conditions they will be working on having the members of the committee call in for a teleconference. The Fire Chief will be at the Main Station if anyone from the public has questions. The meeting will start at 6:30.

#### Time to Prepare for Wildfire Season

Already this year we are starting to see grass fires. Please try to have a 3-foot clear path around your fire so that we can reduce the possibility of a fire getting out of hand. Remember that just because it rains one day the grasses and debris may still be dry and can burn quickly and hot. According to the National Association of State Foresters, nearly 70,000 communities nationwide are at risk from wildfire and our communities are no exception. Embers from a wildfire travel great distances, often causing new wildfires more than a mile from their origin. It can take years for communities like ours to recover from a devastating wildfire. In addition, wildfires cost government, businesses and individuals billions of dollars each year in suppression costs and damage to homes, infrastructure, the economy and resources.

Now is the time for homeowners and communities to safeguard their homes and property from a wildfire threat. As the old saying goes, an ounce of prevention is worth a pound of cure. With some fairly simple steps, every property owner can help protect their home and families as well as their neighbors if a wildfire was to strike.

Wildfire is an inevitable fact of life. Awareness and prevention of those living in fire-prone communities must prepare in advance to mitigate wildfire damage when it occurs. The more proactive actions a community takes, the more *fire adapted* it becomes. The Wildfire threat is a reality throughout Lane County. With a minimal amount of work around your home and property, you can greatly reduce the chance of a wildfire.

The Lowell Fire District is committed to help provide the tools, information and encouragement to prepare for wild-fire and reduce their risk of wildfire in out community. Here are some steps to take around you home:

- 1) Remove dead or overhanging branches. During the windy conditions that exist during a wildland fire, flames, sparks and firebrands could travel from the tree to the roof of a structure.
- 2) Remove leaf, moss and needle accumulation from your yard. Leaf and needle accumulation provide fuel for a wildland fire.
- 3) Remove leaf, needle and moss clutter from your roof and gutters. During a wildland fire, flying embers could ignite this material on the roof and/or in the gutters.
- 4) Remove tall, dry grasses. Tall, dry grasses provide a path for fire that can lead directly to your house.
- 5) Remove "ladder fuels". Prune tree limbs so the lowest is between 6' 10' from the ground. Fire burning through tall, dry grass could ignite these limbs and climb to the top of the tree with relative ease.
- 6) If you have one, check your generator, water system and hoses to be sure they are in good repair. A wildfire could affect electrical power to homes. Refuel garden equipment carefully. Yard equipment needs annual maintenance and proper fueling. Hoses develop leaks and deteriorate with age and exposure. During wildland fire season, fuel your lawn mower properly --away from dry, flammable grasses.
- 7) Prune bushes and shrubs regularly. Remove excess growth as well as dead leaves and branches to decrease their flammability, and the threat they could pose during a wildland fire. Dispose of cuttings and debris promptly, according to local regulations.

#### Lowell, Dexter Lake Farmers Market 2020 Season

The Farmers Market board of directors met on Sunday March 22 by phone conference call. We talked about the Covid-19 infection situation. If it is long lasting, how will it affect our Market season? The board will be evaluating what form the market will take, and when we will be able to open. Last month, we set opening day for May 17th to accommodate sales of garden starts by the high school garden program and other gardeners. We are enthusiastic in our support of local gardening and food resilience. The OSU extension master gardeners want to come out to the market again this year to help with your garden plans and questions. I hope many people are planting their gardens and caring for their fruit trees. We have enjoyed high quality products from local gardeners these past three years.

Oregon licenses farm kitchens and home bakeries. The regulations are somewhat stringent, but licensed people can preserve and sell pickles, acid fruits and berries, and certain other canned goods, as well as baked goods which do not have eggs or dairy as a main ingredient. These programs are administered by the Oregon Department of Agriculture. The products must be sold directly by the cook or baker. They cannot be consigned. Contact the Oregon Department of Agriculture for more information.

The US Department of Agriculture also has programs of interest. They are offering grants for expanding and improving Farmers Markets across the country. We can apply for a grant, even if we are not able to be open this summer. The grant closes at the end of May. We would like to use this grant to put money into the market to help us operate on a truly professional basis.

The prospect for having the market this summer is somewhat hopeful. In the Governor's Executive order 20-12 published March 23, page 4 indicates that certain businesses are exempted. "This Executive Order (of closure) does not apply to restaurants, bars, taverns, brew pubs, wine bars, cafes, food courts, coffee shops, or other similar establishments that offer food or drink, which remain subject to Executive Order No. 20-07 (prohibiting onpremises consumption of food or drink, but allowing take-out or delivery service). Indoor and outdoor malls, and other businesses ... are not prohibited from operating to provide food, grocery, health care, medical, pharmacy, or pet store services."

This list certainly does seem as though it might include farmers markets on a limited basis, for example our consignment stand and one or two other vendors of food which would not be eaten on-site. No social event, just good quality local food to carry home. The social distancing and closure regulations of at least one other state includes farmers markets as "exempt" from closure. The caveat is, strict social distancing must be practiced or the business is shut down.

These are some thoughts on how our market might develop this summer. The board will meet in the coming weeks and we will know more as time goes along.

Volunteer help is always welcome. We are especially looking for someone to help set up an online food ordering system so that consumers, could buy online from local food producers.
