

# Who owns the Grange?

Lowell Grange is not owned by the City but by the Oregon State Grange organization of which Lowell Grange is a member. The Lowell Grange building was built in 1913 as our community's new elementary school, to replace a one-room log schoolhouse located north of the current building. The school district and Hyland family sold the building and land to the Lowell Grange in 1941 when Lundy Elementary opened. Prior to this, Lowell Grange met in the High School. The Grange is a nonprofit, fraternal organization that welcomes new members who are interested in promoting and supporting their community, helping people in need, developing leadership skills and having fun.

#### **City of Lowell Smoke Testing**

The City of Lowell has contracted with Civil West Engineering Services to perform smoke testing of the sewer lines. Smoke testing activities are tentatively scheduled to occur between Wednesday, September 15<sup>th</sup> through Friday, September 17<sup>th</sup>. Smoke testing will be undertaken throughout the community during the week.

Smoke testing is an efficient and cost-effective way to identify system leaks and locations where unwanted storm water is entering the sewer lines. These problem areas are quickly identified by the smoke escaping through the holes in the system and being observed above ground by workers.

During testing, residents may notice smoke escaping from their eaves and yard drains. Smoke should not enter the building unless there exists faulty or improper traps or drains. To minimize the smoke entering your building, please pour water into all drains (sinks, showers, floor drains) prior to the testing. Residents can rest assured that the smoke is non-toxic, non-staining, non-flammable and is harmless to people, animals, and plants.

During testing, smoke should exit the vent stack of houses and possibly escape through manholes. Any other observed smoke may suggest there is a problem with the sewer system. The presence of the smoke in your house can be an indicator that there are available pathways for dangerous and toxic gases entering your house. If this is the case, a plumbing professional should be contacted. If you notice smoke in your house or on your property please report it immediately to the personnel conducting the test or call the City of Lowell City Hall at (541) 937-2157.

### **Planning for Lowell's Future**

Oregon requires cities to publish futuristic Master Plans to help guide Council actions. Master Plans cost \$10,000+ to survey the community, compile results, organize, and have professionals write. Few plans are implemented. Recent Councils and City Administrators have taken a more active approach about enacting your plans. I say "your plans" because we use your money and use your survey responses to develop Master Plans. Implementing the plans are not cheap, but this Council is planning to offset costs by selling City-owned properties. Here is a timetable of what we have done and are planning.

#### Completed

- 2019 Purchased 70 N. Pioneer Street building to replace snow damaged Library and City Hall.
- 2020 Purchased two adjacent properties at Main and Pioneer for a commercial business IAW (in accordance with) the Downtown Plan.
- 2021 Installed an irrigation system in Paul Fisher Park IAW the Parks Plan. Tested wells in Paul Fisher and Rolling Rock Parks for flow.

#### In Process

- 2021 Sell Main and Pioneer property. Also sell City-owned properties at 8 Hyland and the east end of Rolling Rock Park to offset costs.
- 2021/2022 Renovate JW building at 70 N. Pioneer Street.
- 2022 Renovate Rolling Rock Park.
- 2022 Move into new Library and City Hall.
- 2022 New sidewalks and crosswalks around the Main and Pioneer property.
- 2022 Sell present City Hall and Library property.

#### The Goal

By 2023, downtown Lowell will have a new Library and City Hall. Rolling Rock Park will have new walking trails, leveled and irrigated lawns, picnic tables with shade trees, covered pavilion, playground, terraced seating in front of the amphitheater, and more. New sidewalks and crosswalks on Pioneer, Main, and North Shore. New businesses at Main and Pioneer and hopefully across the street on east end of Rolling Rock Park. New home on 8 Hyland, and new residences planned for the present City Hall location. Lowell's future downtown will be amazing and a source of pride.

#### Lowell City Council Actions

On August 3, City Council held special council meeting was held and the following actions were taken:

- Approved Resolution 769, "A resolution to authorize the issuance of a city credit card to the city clerk under the City of Lowell general account."
- Approved the "Professional Services Proposal" from Historical Research Associates, Inc. for a cultural resources inventory in the amount not to exceed \$10,139. Both actions were approved 4:0.

Also on August 3, City Council held a work session and the following topics were discussed:

- Reviewed task outline and fee estimate for landscape architecture services from Dougherty Landscape Architects for the Rolling Rock Park improvements project.
- Reviewed cost estimates from Graham Landscaping for landscaping work around the city.
- Received an update on and discussed the recruitment process for the vacant City Council position.

On August 12, City Council held a work session to follow up on the July 1st visioning workshop and presentation of library design options.

On August 17, City Council held a regular meeting and took the following actions:

- Approved the "Professional Services Proposal" from Historical Research Associates, Inc. for a cultural resources inventory in the amount not to exceed \$10,139 and authorized the City Administrator to sign.
- Approved Estimate #8310 from Graham Landscape and Design, LLC in the amount not to exceed \$5,679.80 and to authorize the City Administrator to sign.
- Appointed Max Baker as City Administrator pro tempore during City Administrator's absence due to a scheduled vacation.
- Appointed Mike Galvin to the City of Lowell Planning Commission.
- Approved and "Exclusive Authorization of Sale" agreement with Campbell Commercial Real Estate for the sale of 8 N. Hyland Lane and to authorize the City Administrator to sign. All actions were approved 4:0.

## "From the Mayor's Desk" by Mayor Don Bennett

The City Council has heard and read your comments about criminal activity. Present and past City Councils have considered the policing issue and identified questions, without answers. What hours should be patrolled? Day, night, staggered? How many officers do we need, where do we get them, at what cost, how do we pay for them? How do we measure the benefit of having our own officer, and what would success look like?

Creswell budgets \$1,000,000 for the services of four deputies and a sergeant from the Lane County Sherriff's Office. Creswell increased their property taxes and added a public safety fee to everyone's monthly utility bill to cover the cost. Veneta and Oakridge are considering adding public safety fees to utility bills to cover increasing policing costs.

The City of Lowell purchases 40 hours of monthly police coverage from Oakridge Police Department. Oakridge PD's staffing will not allow increasing our hours. A few years ago, the City Council considered having our own fulltime officer. Oakridge PD was the cheapest option. They would hire and train our officer. The officer's salary, benefits, training, and support equipment could total over \$140,000 per year. Splitting the cost between the 450 homes in Lowell could cost each household more than \$300 per year.

Until Lowell can afford a dedicated officer, City Staff is working closely with Oakridge PD to direct local patrols to areas where citizens have submitted complaints.

## FROM THE LOWELL FIRE DISTRICT

#### A Reminder that Fire Season Is Not Over Yet

Fire Season is still with us and it is important to keep fire safety in mind at all times. Outdoor burning is prohibited and may open in October depending on weather and environmental conditions. Campfires and/or warming fires in most locations are prohibited and will remain prohibited until vegetation fire levels are greatly reduced by significant moisture. Contact the district office for more information on current fire safety considerations in the area.

Please also make sure that we leave the roadways open for fire personnel to respond when they are needed. It is very important to us to keep our community safe. While we appreciate the offer of assistance, we have the proper protection and training to get the job done safely.

#### **Ever Think About Becoming A Firefighter?**

Ever want to do something new and exciting? Want to learn new and valuable life skills? Think about joining the Fire Service and help your community.

Volunteers are critical to our nation's fire and emergency services. 69% (or 786,150) of firefighters in the U.S. are volunteers. These volunteers save communities \$140 billion annually. However, the number of volunteers has declined by about 12% since 1984. During the same timeframe, call volume has nearly tripled, largely due to the increase in Emergency Medical Service (EMS) calls. In 2013, there were over 31 million calls to local fire departments.

The volunteer fire service is an aging population. Since 2000, there has been a 14.9 percent drop in the number of firefighters under the age of 40 in communities like ours. Communities our size rely almost entirely on volunteers.

There are many reasons for these trends, including:

- increased time demands placed on firefighters and EMTs or more rigorous training requirements
- proliferation of two-income families whose members have less available time
- younger people moving out of smaller communities for better job opportunities

The Lowell Rural Fire Protection District is almost all Volunteer. We have a full-time (40+ hour per week) paid Fire Chief and 3 full-time (48/96) paid Shift Officers.

The District currently has three Resident Volunteer Firefighter/EMTs, 14 shift Volunteer Firefighter/EMTs and five Volunteer cadet Firefighter/EMTs. The District needs more volunteer members to help protect the communities of Lowell, Fall Creek and Unity. You will receive all the training you want locally; all you need to do is apply.
